Creating an Account

Step 1:

Start by clicking on one of the log in options located on the top of the Request Dupliate Title application.

Dealer Dashboard

The Dealer Dashboard enables dealers to log in, start a new form, save an existing form, and view the progress of a form that has been submitted.



Navigation Bar



To log in, select the log in option in the navigation section of the form. Log in with the credential from the account you created or one of the other account options listed. You may submit a duplicate title application without logging in. Please note, your forms will not be available if you clear your cache or log in from a different pc. Submitting forms while logged in is the only way to ensure your information is available when accessing the dealer dashboard.

A partially completed form can be accessed by going to the "To Do" option under my forms. You may choose to continue or delete a form that you have not yet submitted.



In Progress:

Forms that have been submitted and are being processed by the WV DMV are located under "In Progress". No changes may be made to forms that have been submitted. You are however able to download submitted forms.
