This project is located on the West Virginia Turnpike and consists of fully repainting the steelwork, coating all substructure units and the exterior face of the parapet walls including overhangs for Bridge 3034N. There is approximately 70,400 square feet of steelwork to be painted and approximately 25,700 square feet of concrete to be coated.
