PROJECT OVERVIEW



Portions of the former Hobet mining complex are slated for development in Boone County, WV north of Danville, WV near Rock Creek. Current access to U.S. Route 119 from the property is a former haul road connecting to Boone County Route 119/67 east of the area.

The purpose of this project is to improve the access to the development area for the use of private owned and commercial vehicles.




ABOVE: The existing access is a narrow and steep haul road with sharp turns. The winding switchbacks require slow speeds and would be difficult for commercial vehicles to safely negotiate.

LEFT: The grade of the existing road at times exceeds 10%. Maximum design grade is 8%, which allows a safer, more practical access for conventional vehicles.


